In exercise of powers conferred by sub section (2) of section 131 of the Electricity Act, 2003 (Central Act 36 of 2003) read with sub-clause (2) of clause 9 of Kerala Electricity Second Transfer Scheme (Re-vesting), 2013, the Government of Kerala hereby make the following Scheme further to amend the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013, issued under the G. O. (P) No. 46/2013/PD dated 31st October 2013 and published as S. R. O. No. 871/2013 in the Kerala Gazette Extraordinary No. 3103 dated 31st October, 2013, namely:—



SCHEME

1. *Short title and commencement.*—(1) This scheme may be called the Kerala Electricity Second Transfer Amendment Scheme (Re-vesting), 2023.

(2) It shall come into force at once.

2. *Amendment of the Scheme.*—(1) In the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013, sub-clause (9) of the clause 6 of the said Scheme shall be omitted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport).

As part of re-organisation of Kerala State Electricity Board and in exercise of the powers conferred under Section 131 and 133 of the Electricity Act, 2003 (Central Act 36 of 2003), the Government of Kerala took over all the functions, properties and all interests, rights in properties, all rights and liabilities of the Kerala State Electricity Board as per the Kerala Electricity First Transfer Scheme issued by notification under G. O. (Ms.) No. 37/2008/PD dated 25th September, 2008, and published as S. R. O. No. 990/2008 in the Kerala Gazette Extraordinary No. 2090 dated 25th September, 2008: Under sub clause (1) of Clause 6 of the said Scheme, Government have issued the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013 under G. O. (P) No. 46/2013/PD dated 31st October, 2013, and published as S. R. O. No. 871/2013 in the Kerala Gazette Extraordinary No. 3103 dated 31st October, 2013 re-vesting all the functions, properties and all interest, rights in properties, all rights and liabilities vested in the State Government to a company.

As per sub-clause (2) of clause 9 of the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013, Government have decided to amend certain clauses of the Kerala State



Electricity Second Transfer Scheme (Re-vesting), 2013, since the period allowed for retention of Electricity duty collected by Kerala State Electricity Board Limited ends on 31st October 2023. Now, Government have decided to dispense with the system of retaining electricity duty collected by Kerala State Electricity Board Limited from customers with effect from 1st November, 2023. The Electricity duty collected by Kerala State Electricity Board Limited from 1st November, 2023 onwards shall be remitted to Government in Head of Account 0043-102-99-receipt as declared in the Budget Speech for 2023-2024, after retaining 1% of the total duty collected as collection charge.

The notification is intended to achieve the above object.
