ORDER

Kerala State Electricity Board Ltd vide B.O(FM) No: 2559/2013(TC5-1260/98) dated 30.11.2013 has accorded sanction to the following.

- 1. To realize applicable HRA only from the employees of Kerala State Electricity Board Ltd toward's rent of Board's quarters allocated to employees within Headquarters.
- 2. To revise the concessional rent of the Board's Quarters at various places allotted to employees of Government Departments / Public Sector undertakings and the above concessional rent will be allowed only for those who forward their application through their controlling officers and only after executing necessary agreements. Those who fail to comply with these conditions shall pay the penal rent equal to two times the normal rent.
- 3. The rent payable by the offices of other Government Department /Public Sector Undertakings occupying Board's building/Quarter's for office purpose be as per the rent fixed based on Kerala PWD Schedule of rates in force in line with the pattern adopted by the Board for payment for rent of building taken on hire by the Board.
- 4. To revise the rent of Inspection Bungalows of Kerala State Electricity Board Ltd .

Consequent to the issuance of above Board order the following issues were brought to the notice of the Board.

Realization of applicable HRA only from the employees of Kerala State

Electricity Board Ltd toward's rent of Board's quarters allocated to

employees within Headquarters.

The General Secretary, KSEB Workers Association vide letter read as 4th paper above has submitted a representation to the Chairman & Managing Director of Kerala State Electricity Board Ltd pointing out that the rent of quarters allocated to KSEB employees is fixed as per long term settlement and the monthly rent for Board's quarters allotted to Board employees is being realized as per the long term settlement 2000 Article-X F para 13. It is also pointed out that before making any modification to matters included in the long term settlement discussions has to be made with the recognised trade unions who had entered into agreement with the Board and hence requested to cancel this clause in the B.O read as 1st paper above. Also requested that any further decisions in this matter may be made only after a discussing with the recognized trade unions.

Revision of rent of Munnar House IB for personal purpose

As per B.O read as 2nd paper above, the Munnar House has been categorized as A grade Inspection Bungalow and a higher rate of rent of Rs 250/bed/day was fixed for personal purpose from officers and staff of KSEB to give priority to officers on duty (not within their headquarters). The rent for others are fixed at Rs 500/bed/gay.

As per the B.O dated 30/11/2013 the rent for Munnar House was fixed as same as to other A grade Inspection Bungalows. The rent fixed for officers and staff on personal purpose and family members accompanying the officer for Non A/c room is only Rs 80/bed/day and for others is Rs 400/bed/day Hence the rent fixed for the above group of occupants for Munnar House has come down than the rent prevalent as per B.O dated 18/6/2011.

The above issues were discussed in the meeting of Full Time Director of Kerala State Electricity Board Ltd held on 8.1.2014 and decided to modifithe B.O(FM) No: 2559/2013(TC5-1260/98) dated 30.11.2013 to the following extent

Cancel the decision to realize applicable HRA only from the employees sues of Kerala State Electricity Board Ltd towards rent of Board's quarters allocated employees within Headquarters and to continue the practice as being ate followed based on long term settlement till a settlement is arrived with to recognized trade unions.

It was also decided that Kerala State Electricity Board Ltd will initiate discussions with the recognized trade unions regarding revision of rent of quarters of Kerala State Electricity Board Ltd allotted to employees.

The B.O read as 1st paper above stands modified to the above extent and orders are issued accordingly.
