ORDER

In exercise of powers conferred under Section 131 and 133 of the Electricity Act, 2003 (Central Act 36 of 2003), Government have re-structured the erst- while Kerala State Electricity Board as a company, constituted under the Indian Companies Act 1956 (Central Act 1 of 1956), in the place of KSEB, viz, the Kerala State Electricity Board Limited, incorporated on 14-01-2011, with Corporate Identity No. U 40100/KL/2011 SGC 027424 ,as per the Kerala Electricity Second Transfer Scheme (Re-vesting), 2013, vide G.O. , read as first paper above and Government have amended certain clauses of the Transfer Scheme (Re-vesting), by issuing the Kerala Electricity Second Transfer (Amendment) Scheme (Re-vesting), 2014, as per G.O. , read as second paper above As per sub-clause (7) of Clause 2 of the Kerala Electricity Second Transfer (Amendment) Scheme (Re-vesting), 2014, personnel recruitment and selection will be made through Kerala Public Service Commission as was done immediately before the date of the transfer.

2. The Kerala State Electricity Board Limited is a ' Government Company' as defined under Section 2(b) of the Kerala Public Service Commission (Additional Functions as Respects Certain Corporations and Companies) Act, 1970 (Act 19 of 1970). By virtue of section 3(2) of the Act, the Board of Directors of a Government Company may consult the Public Service Commission.

(a) on all matters relating to the methods of recruitment of the employees of that Government Company;

(b) on the principles to be followed in making appointments by direct recruitment of the employees of that Government Company and on the suitability of the candidates for such appointment.

3. Government Companies, coming under the purview of the aforesaid Act have been specified in clause (d) of rule 2 in the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, made under the Act. Government are, therefore, pleased to order that the Kerala State Electricity Board Limited shall also be included in the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971, so that this Company can seek the advice of the Kerala Public Service Commission on the matters relating to the methods of recruitment of its employees.

4. Separate orders will be issued accordingly by amending the Kerala Public Service Commission (Consultation by Corporations and Companies) Rules, 1971 .
