ORDER

WP(C) No.33771/2017 was filed by Overseers (Ele.) (Diploma holders), with the prayer that their juniors having ITI qualification were promoted to the cadre of Sub Engineers as per Exhibit P8 Order dated 31.03.2017, overlooking their claim. Petitioner's main contention was that their qualification of Three year Diploma Course in Electrical Engineering from the Central Polytechnic College, Thiruvananthapuram is a prescribed qualification in the Board Order dated 23.01.1981.

The Hon'ble High Court in its Judgment dated 23.01.2019 in WP (C) 33771 of 2017 held that as per the qualification prescribed in the Board Order dated 23.01.1981, the petitioners were eligible for promotion to the cadre of Sub Engineers as on the date on which promotions were granted to their juniors and hence the promotion granted to the juniors as per Ext. P8 list, overlooking the claim of the petitioners cannot be sustainable. The Hon'ble Court made it clear that since the petitioners have not impleaded those juniors, who are granted promotion, the promotions held so far do not require interference. Based on the submission of the petitioners that there are sufficient number of vacancies, the Hon'ble High Court held that if that be so, the Board shall consider the claim of the petitioners and grant them promotion with effect from the date on which promotions were granted to their juniors with all consequential benefits except arrears of pay, within a period of 'two months' from the date of receipt of a copy of the Judgment.

The Board examined the Judgment read above in detail and found that the scope of an appeal against it is very remote. Hence decided to comply with the same by giving promotion to the petitioners, as per the prevailing rules and norms.

The Chief Engineer (HRM), KSEB Limited shall expedite necessary steps for the compliance of the above judgment.


