ORDER

In the order read as 3rd paper above, 35 promotions were ordered from the cadre of Overseer to the cadre of Sub Engineer (Ele) against 10% quota set apart for qualified Overseers having 5 years experience in that cadre. Their seniority was fixed with respect to their actual experience/length of service in the cadre of Overseer. On further scrutiny, it has been identified that some errors have occurred in the promotion order, and hence some revisions/changes are seen needed in it. Hence the undersigned decided to review the promotions ordered vide proceedings read as 3rd paper above and revised as enlisted herewith subject to the conditions stipulated hereunder:

- 1) The promotions are ordered in exigency of service and in public interest.
- 2) The promotions are purely provisional under Rule 31(a)(i) of the KS7SSR 1958 as adopted by the Board.
- 3) Corrections (if any) in the date of entry in service as Overseer, which may affect the gradation of the incumbent may be brought to the notice of the undersigned with documentary evidence without delay.
- 4) Changes (if any) in serial number should be noted in the Service Book.
