Abstract

Granting of time—bound higher grade promotion – Counting of War/Military Service – Sanctioned – Orders issued.

ORDER

In compliance of the Judgement of the Hon'ble Supreme Court of India, the Government of Kerala issued orders vide Government Order read above wherein, it has been ordered that "ex-service men who were under war/military service and got appointment in the state civil services are eligible to get the benefit of first time-bound higher grade by counting their war/military service without refunding their mustering out benefits".

In KSEB Limited, reckoning of war/military service for granting time-bound higher grade is regulated by Board Orders issued from time to time. As per orders now in force in KSEB Limited, war/military service is reckoned for granting 1st, 2nd and 3rd higher grades.

The matter of adoption of the Government Order read above came up for consideration with the Board. Since the said Government Order was silent about granting of the 2nd and 3rd time bound higher grades, it was decided to obtain a clarification from the Government on the issue. While so, certain employees, being beneficiaries of the provisions of the Government Order, approached the Hon'ble High Court of Kerala and filed WP (C) No. 20256/2017. Upon this, the Hon'ble High Court directed the Board to consider the admissibility of the 1st time-bound higher grade. After examining the matter the Board issued order read 2nd above for adopting the Government Order read above.

Later, the Government vide their letter read 3rd above clarified that the employees of KSEB Limited, which is a Public Sector Undertaking, are not eligible for the benefits contemplated in the Government Order dated 14.09.2015 and extending the benefits of the said Government Order to the employees of KSEBL is irregular.

Since the Government have clarified vide their letter read 3st above that the said order is applicable only to employees in state Government service and adoption of the Government Order dated 14.09.2015 in KSEB Limited is irregular, the matter was taken up with the Full Time Directors. Having considered the matter in detail the Board is pleased to order not to adopt G O (P) No. 408/2015/Fin dated 14.09.2015 and to cancel B O (FTD) No. 532/2018 (LAS-III/4801/2017) dated 27.02.2018. It is further ordered that the present system of granting time-bound higher grade will continue until further orders.
