## **ORDER**

The revision of pension to the pensioners of Kerala State Electricity Board Limited is undertaken after revision of pay and allowances of workmen and officers. The discussions/negotiation with the trade union of Kerala State Electricity Board Limited for the revision of pay and allowances of workmen have been concluded. Similarly the revision of pay and allowances of officers has also been completed.

In the State Government, the State Pay Commission has proposed to revise the pension of State Government pensioners.

As per the practice hitherto followed in Kerala State Electricity Board Limited, the revision of pension is carried out after the conclusion of revision of pay and allowances of workmen and officers and the revision of pension to State Government employees. The pension revision process in Kerala State Electricity Board Limited has to be completed in a time bound manner considering all relevant factors.


