ORDER

As per the directions contained in the letter read as 1st paper above, KSEBL has issued instructions to all officials to take immediate action to remove the advertisements / hoardings / banners / posters and paintings from KSEBL premises / offices / poles. Now the Chief Electoral Officer has informed that in various roads and interior lanes of Thiruvananthapuram City, poles of KSEBL are still seen painted with advertisements of various political parties and hence has directed to remove all such advertisements immediately and to report compliance.

Even though all such advertisements / banners / posters and paintings were removed from the poles of KSEBL as per the reports from field there may be chances that the same practice can be repeated by political parties. Hence a Committee with the following Members are hereby constituted for monitoring and ensuring the observance of Model Code of Conduct in respect of the displays made in poles of KSEBL.
