ORDER

A number of senior officers of the Kerala State Electricity Board Limited are due to retire on Superannuation in the months of February, March and April 2021. Most of these officers presently hold crucial positions that are pivotal to the essential organizational function of maintaining uninterrupted power supply. The General Elections 2021 to the Kerala Legislative Assembly is slated to take place in March – April 2021, with the preparatory and culmination phases extending to the months of February and May 2021. Maintenance of uninterrupted power supply and associated functions assume utmost importance during the general elections and associated process. As such, it is to be ensured that the positions above that are responsible for proper co-ordination and timely decision making required for unhindered and efficient execution of basic organizational functions remain occupied continuously during the period.
