ORDER

KSEB Ltd. as per Office Order read as 1st above has constituted 14 District Level Committees for prioritizing the list for Medical Protection / Protection for differently abled / fixing medical weightage for the forth coming General Transfer 2020 of officer cadres. Each committee consists, besides convenor and two official members, one representative each from three recognized officers Associations, namely, KSEB Officers' Association, KSEB Engineers' Association and Kerala Power Board Officers' Federation.

Now, Kerala Electricity Officers' Confederation has submitted a representation, read (2) above, before the Chairman & Managing Director of KSEB Ltd., with a prayer to include their representatives also in the District Level Committees, which had been transmitted to the office of the Chief Engineer(HRM) by the Chairman & Managing Director to examine the matter. Vide reference (3), a detailed note had been submitted by the Chief Engineer(HRM) to the Chairman & Managing Director through the Director (Dis. IT & HRM).

After analyzing the matter in detail, Chairman & Managing Director, has ordered on 30.05.2020, that in 10 Districts, the representatives of Kerala Power Board officers' Federation may be included and in remaining 4 districts, representatives of Kerala Electricity Officers' Confederation may be included. On 05.06.2020, the Director (Dis. IT & HRM) further directed that the District Level Committees of Thiruvananthapuram, Kollam, Kottayam and Ernakulam shall be reconstituted in such a way that the representatives of Kerala Electricity Officers' Confederation shall be included by replacing the representatives of Kerala Power Board Officers' Federation. In the remaining districts, the existing committees shall continue.

Also, the representative of Kerala Power Board Officers' Federation in the District Level Committee of Kozhikode had retired from Board service on 31.05.2020 and, vide the letter read as (4) above, the Association has recommended another employee as their representative in the respective committee.

As directed by the Director (Dis. IT & HRM), the office order read as (1) above, is partially modified as follows.
