CIRCULAR

Sub:- Request for refund of one day's pension amount deducted from Service Pensioners/
Family Pensioners towards CMDRF (Vaccine Challenge) – instructions issued.

Ref:- 1. Letter dtd. 30.04.2021 of the General Secretary, KSEB Pensioners Association.

The former Minister for Electricity has convened a meeting with the representatives of Trade Unions & Association of Officers of KSEB Ltd on 29.04.2021 and made an appeal to contribute generously to the CMDRF (Vaccine Challenge). A great majority of the organisations have agreed to contribute one day's Salary to the CMDRF towards Vaccine Challenge Campaign .

The General Secretary KSEB Pensioners' Association, vide reference 1st cited, has expressed the willingness of the Members of the Association to contribute one day's pension to the CMDRF (Vaccine Challenge) from the monthly pension for June 2021.

In accordance with the decision taken in the meeting held on 29.04.2021 and based on the willingness conveyed by the KSEB Pensioners Association, instructions were issued, vide reference 2nd cited, to deduct one day's Salary from the employees of KSEB Ltd for the month of May 2021 and one day's pension from the Service/Family Pensioners for the month of June 2021 towards CMDRF (Vaccine Challenge).

Thereafter, a section of pensioners have demanded in writing to refund the amount deducted from their pension, for the month of June 2021, towards CMDRF (Vaccine Challenge), on the ground that they have not consented in writing to deduct such amounts from their monthly pension.

Having considered the request of the pensioners, the ARU heads are instructed to refund the amount deducted from the monthly pension for the month of June 2021, towards CMDRF (Vaccine Challenge) to those pensioners who have submitted requests for getting refund of the amount deducted from them.
