#### **ORDER**

A Nomination list consisting of 8 Divisional Accounts Officers, who are eligible for considering promotion to the cadre of Assistant Finance Officers were tabulated and prepared based on the benchmark grading issued by the Secretary(Admn.) and was placed before the DPC(Lower) held on 28.10.2021. Accordingly nomination list was approved and the DPC(L) has decided to prepare a Select List of 4 eligible candidates and Promotion Orders were issued. Later it was noted that, among the list, the probation of the fourth nominee Smt.Suchithra.M.L, Emp.Code:1100335, Divisional Accounts Officer, Electrical Division Aluva has not declared in the service of KSEBL or in the cadre of Divisional Accounts Officer. As the declaration of probation is one of the eligibility criteria for considering promotion, the incumbent found not eligible for considering promotion.

The matter was taken up with the adhoc meeting of DPC(L) held on 25.11.2021 and the DPC(L) has issued directions for revising the nomination list to the extent belonging to the nominee Smt.Suchithra.M.L, keeping her name under withheld status in the nomination

list.Also the DPC(L) issued direction to cancel the promotion ordered to Smt.Suchithra.M.L, and to consider the next eligible candidate in the vacancy so arrived.

In the light of the above, the following Select list of Divisional Accounts Officer is ordered for considering promotion to the cadre of Assistant Finance Officer. Also the name of the 4<sup>th</sup> candidate Smt. Suchithra.M.L, Emp.Code:1100335 in the Select list order read 2<sup>nd</sup> above stands cancelled.
