ORDER

The Chief Engineer (HRM), as per note read as 1st above had furnished the present staff strength details of Assistant Engineer (Civil) as follows:

- Among the 95 vacancies under 40% direct recruitment quota, 39 vacancies have already been reported to the PSC, but no advice has been made by the PSC. Therefore in the 40% PSC quota there are 56 vacancies remaining to be reported to the KPSC.
- Among the 32 vacancies under 10% in-service quota, 29 vacancies have already ii. been reported to the PSC, but no advice has been made so far. Thus in the 10% in-service quota there are 3 vacancies remaining to be reported to the KPSC.

Therefore the Chief Engineer (HRM) sought sanction to report the vacancies of Assistant Engineer (Civil) under 40% direct recruitment quota and 10% in-service quota remaining to be reported to the KPSC. As ordered by the Chairman & Managing Director, the matter was placed before the Full Time Directors as per note read as 2nd above.

Having examined the matter in detail, the Full Time Directors in its meeting held on 18.01.2022 resolved to accord sanction to the Chief Engineer (HRM) to report 56 vacancies of Assistant Engineers (Civil) under 40% direct recruitment quota and 3 vacancies under 10% in-service quota, which are the vacancies remaining to be reported to the KPSC.

The Chief Engineer (HRM) shall take further necessary action in the matter.

Orders are issued accordingly.
