## ORDER

The Chief Engineer (Civil - Dam Safety & DRIP) as per the note read as 1<sup>st</sup> above has requested sanction for the purchase of a new car, as the existing vehicle attached to the office of the Chief Engineer (Civil-Dam Safety & DRIP) purchased in 2015 has traversed more than 1.30 Lakh kilometers and has now developed complaints and requires major repairs. Considering the vast jurisdiction of the Dam Safety wing, KSEBL as per B.O. read as 2<sup>nd</sup> above has accorded sanction for the purchase of an INNOVA Crysta Car (Diesel) through GEM portal for the official use of the Chief Engineer (Civil- Dam Safety & DRIP). But the above purchase was not materialised due to the non availability of the above vehicle in GEM portal.

Considering the importance of Project inspections by the Director (Generation-Civil), a new Innova Crysta is to be purchased for the official use of the Director (Generation-Civil) and thus the existing Innova car now being used by the Director (Generation Civil) can be spared for the official use of the Chief Engineer (Civil-Dam Safety & DRIP).

The matter was placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 13.06.2022, resolved to accord sanction for the purchase of an Innova Crysta Car (Diesel-2.4 GX MT-7 seater) for the official use of the Director (Generation-Civil), with a financial commitment of ₹24,01,000 (Rupees Twenty Four Lakh One Thousand only), after observing all the formalities prevailing in KSEBL.

Further resolved to authorize the Chief Engineer (SCM) to arrange the procurement of the vehicle and to maintain the same under the Vehicle Monitoring Cell, Vydyuthi Bhavanam, Thiruvananthapuram.

Further resolved that the existing vehicle (KL-01 BQ 2496) now being used by the Director (Generation-Civil) shall be spared for the official use of the Chief Engineer (Civil-Dam Safety & DRIP) and the vehicle (KL-01 BW 8457) now being used by the Chief Engineer (Civil-DS & DRIP) shall be repaired and spared to any officers having limited area of jurisdiction.

Further resolved to modify the Board Order B.O. (FTD) No.124/2022 (DGC/AEEII/Vehicle/2022) dated 18.02.2022 to the above extent.
