## ORDER

The Chairman & Managing Director, KSEB Ltd has ordered that during the ensuing online transfer of officers the working strength in Vydyuthi Bhavanam, Thiruvananthapuram may be treated as one unit and no option for individual seat/post shall be collected from officers who opt for posting in the Corporate Office, Vydyuthi Bhavanam, Thiruvananthapuram. Only preference to work with an individual Head of Department may be collected from all the Heads of Departments/Offices in Vyduythi Bhavanam and a Committee shall assign the individual seat or post to the transferee by aligning the option with the suitability of the candidate. Change of seat within Vydyuthi Bhavanam, Thiruvananthapuram (Corporate Office) during the Online General Transfer may be decided by the above committee or the Director in charge of HRM in consultation with the committee and such in-seat-to transfer in Vydyuthi Bhavanam may not be counted as transfer in the general profile.

The Director (Finance, IT & HRM) recommended to constitute the committee with only Full Time Directors, Chief Personnel Officer and Chief Engineer (HRM) as convenor. Accordingly, Chairman has accorded sanction to constitute the Committee for the above purpose as below:-

- 1. The Director (Finance, IT & HRM) (Chairman of the committee)
- 2. The Director (REES, SOURA, NILAAVU Project, Sports & Welfare)

- 3. The Director (Generation-Electrical)
- 4. The Director (Generation-Civil)
- 5. The Director (Distribution & Supply Chain Management)
- 6. The Director (Transmission, System Operation, Planning & Safety)
- 7. The Chief Engineer (HRM) (Convenor of the committee)
- 8. The Chief Personnel Officer

The Committee shall allocate the officers in the best interest of the organization considering the options given by the officers as well.
