ORDER

As part of promoting energy conservation and efficiency, around 1.5 crore LED bulbs were purchased through EESL and 1.4749 crore bulbs were sold @ Rs 95 per bulb initially and Rs 60 per bulb later under Domestic Efficient Lighting Programme (DELP) scheme.

Currently, 1.83 lakh LED bulbs under the scheme are available in 16 out of the total 25 Electrical Circle stores accumulated through replacements of bulbs under warranty period and the Buffer stock. Besides, warranty of these bulbs has expired and the bulbs are also causing space constraints in circle stores. As warranty period of the bulbs has expired, sale of these bulbs may not be advisable.

The matter was placed before the Full Time Directors as per note read as 5th above. Having considered the matter in detail, the Full Time Directors in its meeting held on 29.08.2022, resolved to accord sanction for the following.

1. To direct all Deputy Chief Engineer, Electrical Circles to make arrangements to disburse the LED Bulbs under DELP Scheme within one month.

2. To direct the Deputy Chief Engineer, Electrical Circles to distribute the LED bulbs among all 25 Regional Stores under every Electrical Circle since available 1.83 lakh bulbs are at 16 SRS.
3. To direct the Deputy Chief Engineer, Electrical Circles to ensure that every office under Transmission, Distribution and Generation shall be given at least 5 numbers of LED Bulbs in each office and to ensure that all Incandescent / CFL bulbs shall be replaced with LED Bulbs.
4. To entrust the Deputy Chief Engineer, Electrical Circles, to arrange distribution of 10 numbers of LED Bulbs to each Government Hospitals and to maintain 5 numbers LED bulbs each as spare and to ensure that Incandescent / CFL Bulbs are replaced with LED bulbs.
5. To replace the incandescent / CFL Bulbs in all Anganavadis / Libraries coming under Library Council, with LED Bulbs and two numbers of LED Bulbs may be allocated to Anganavadis as spare.
6. To allot all NPG and consumers having consumption below 50 units two numbers of LED Bulbs free of cost.
7. To entrust the Chief Engineer, Distribution (North, Central and South) to co-ordinate the activities related to distribution of available LEDs at SRS.

Orders are issued accordingly.
