

ORDER

Registrar of Trade Unions (Labour Commissioner) as per order read as 1st paper appointed the Regional Joint Labour Commissioner as the Returning Officer for conducting Referendum in Kerala State Electricity Board Limited and the Referendum was conducted on 20-10-2015.

The Returning Officer (Regional Joint Labour Commissioner) Ernakulam, as per order read as 2nd paper has furnished the statement of results and the share of votes secured by each trade union in the Referendum.

As per the above order, the following trade unions have secured adequate percentage of votes necessary for considering them to be treated as principal bargaining agent and Constituent Joint bargaining council as per the relevant provisions of Kerala Recognition of Trade Unions Act, 2010.
