**ORDER**

Chickenpox was listed as 2<sup>nd</sup> among the contagious diseases for granting Special Casual leave as per Appendix VII, Section II, Rule1(1) KSRs. But it was later removed from the list. By now, as per the G.O read as 1<sup>st</sup> above Government have included Chickenpox in the list of contagious diseases eligible for Special Casual Leave.

The Chief Engineer (HRM) as per the note read as 2<sup>nd</sup> above has requested clarification whether KSEBL has adopted the G.O. read as 1<sup>st</sup> above for including Chickenpox in the list of contagious diseases in KSR for which Special Casual Leave shall be granted.

On placing the matter, Director(Finance & HRM) KSEBL, has directed to bring the matter before Full Time Directors of KSEBL for decision. Accordingly the matter has been placed before the Full Time Directors of KSEBL as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors of KSEBL through circulation have resolved to accord sanction for adopting the G.O.(P) No.10/2024/FIN dated 16.02.2024 for implementation in KSEBL.
