### **ORDER**

Vide Order read 1st, 64 Senior Assistants who were included in the Select List read 4th were temporarily promoted to the cadre of Senior Superintendents as per Rule 31(a) Part II of the KS&SSR 1958.

They were temporarily promoted to the cadre of Senior Superintendent as the vacancies arised were temporary based on the temporary promotion of Senior Superintendents to the cadre of Assistant Accounts Officer vide Order dated 21.11.2023. Now regular vacancies has arisen due to the retirement vacancy upto 31<sup>st</sup> May 2024 on superannuation.

Having considered the above, the temporary promoted persons figured in the list appended to the cadre of Senior Superintendents are hereby regularized with effect from the date noted against them,subject to the relevant provisions of Rule 28 of KS&SSR, subject to the general conditions mentioned hereunder. Controlling Officers shall ensure their declaration of probation in the promoted post immediately on successful completion of their probation ensuring their successful completion of mandatory orientation level training program for Senior Superintendent. Necessary entries in this regard shall be made in their Service Book and HRIS .

Sri. Mohammad Ali Manu F (Sl. No 56) was retained as Senior Assistant on the aegis of the interim Order in WPC No 7985/2024. Having considered the final Judgment in the WPC and the regular vacancies arised in the cadre of Senior Superintendents, his temporary promotion in the cadre of Senior Superintendent is regularized wef the date of this order.
