3. Tripartite Agreement

As per the reference cited Government have constituted a committee to examine the various issues raised by NCCOEEE, in KSEBL including pension Master Trust, Government order dated 1.11.2023 etc. The committee constituted is illegal and irregular and void abinitio. NCCOEEE announced a strike in KSEBL and finally not gone on strike. The some of the committee members reference 1, are not related to any trade union in KSEBL. NCCOEEE is not registered under Trade Union Act. The different official meetings with trade unions, officers organisation in KSEB, NCCOEEE was not an invite till date. The list of trade unions, officer organisation are with board and same could be verified by your office. No minutes of such meeting could be produced by the KSEBL management before the public or Unions.

Also it is point out that the allied strike or meetings of officers with trade union are not allowed by the board. The right of trade unions cannot be used by officers. As per Kerala Government Service Conduct Rules 1960, the provisions in rules 76 to 79 shall not apply to employees in subordinate service in Government owed industrial concerns. KSEBL will come under "subordinate industrial concern" and hence trade unions have the right to strike, politics etc, but the officers organisations have no such right. The Government order vide reference 1 is against law. Some of the members in the sub

committee are not an office bearer in any of the trade unions. We Kerala Electricity Employees Confederation (INTUC) also raised many issues and went on strike on 22.1.2025. The issues raised by the other unions and We Kerala Electricity Employees Confederation (INTUC) are almost same such as DA, Promotion, Master Trust etc. Also it is informed that the issues in the Master Trust, rectification of orders 1.11.2023 related to master trust could be sorted out by the committee including members of the unions/officers organisation, those who have signed in the tripartite agreement. This was informed you earlier vide reference 2. The referred committee does not included all the unions representative who have signed in the tripartite agreement signed on 1.8.2014, (Reference 3).

It is informed that the committee without the representatives signed in the tripartite agreement is void abinitio. Also informed that there is no trade union or officer organisation in KSEBL in the name NCCOEEE, and informed that the joint venture of trade union and officers is against service conduct rules 1960. As per rule 7(6) (2), the officer Associations shall not announces to any strike or threat of strike as a means of achieving any of its purposes or for any other reason. In KSEBL NCCOEEE announced a strike and the activities of the officer organisation belongs to this federation is illegal. It is prima facie proved by the referred Government order because it consisting members of both trade union and officer organisations. At present the activities of officers in the name of joint venture NCCOEEE to be prohibited. The Government, Board, Minister, Power Secretary, Chairman & Managing Director are all involved in this serious wrong illegal manipulation.

In this connection we request your goodself to cancel the above reffered Government order and issue a new orders incorporating all the trade unions/officers organisation in KSEBL. Especially those who were signed in the tripartite agreement signed on 1.8.2024, and not based on the notice of NCCOEEE.
