## ORDER

3. At present, there are two posts of Deputy Chief Engineer (Civil) in the office of the Chief Engineer (Civil) Construction South. One Deputy Chief Engineer is looking after the contract matters of the ongoing projects and the other is in charge of design of various projects. Board has also constituted a new cell called SPIN (Sports, Pre-Engineered Infrastructure and New Technology) which is mainly intended for construction of various buildings using new and innovative technologies such as prefab. KSEB Limited has also been accredited by the Government of Kerala to execute public works. Also, KSEB Limited has sufficient inhouse expertise to have consultancy wing in Civil Construction works so as to claim consultancy / centage charges from other departments.

4. Considering the above, one post of Deputy Chief Engineer (Civil) from the office of the Chief Engineer (Civil) Construction South is shifted to the office of the Chief Engineer (Dam Safety & DRIP) to handle SPIN and consultancy activities. The other Deputy Chief Engineer in the office of the Chief Engineer (Civil) Construction South will look after the contract matters and design activities.


