## ORDER

Based on requests from the recognised General Trade Unions, the Board decided to conduct computerised online general transfer from the year 2017 onwards. This necessitated modifications in the prevailing guidelines for transfers and postings. Several rounds of discussions were held with the recognised General Trade Unions and a consensus regarding the modus operandi to be followed was arrived at. Accordingly, a revised draft of transfer guidelines was uploaded in the official website of KSEBL for all concerned to express suggestions etc. After considering the suggestions received and since the process of transfer was to be completed before the reopening of educational institutions, the Full Time Directors decided to implement the guidelines and accordingly the Board Order read as 2<sup>nd</sup> paper above was issued.

The matter was then placed before the meeting of the Board of Directors held on 12.04.2017, vide agenda item No. 51-04/2017, for ratification. After careful examination of the various aspects involved, the Board is pleased to ratify the decision of the Full Time Directors to accord sanction to revise the Transfer Guidelines of workmen of KSEBL, incorporating the following modifications:

- a) To replace the term 'Malabar area' with 'Northern Kerala' under clause VI.
- b) To include the following sentence under clause VII (r):"Such list of Sports men/Sports women will be published in the website of the Company."
- c) The following sentence to be inserted under Note 2 to clause II:

"Change in domicile is restricted to two times in the entire service. Any exemption to this will be with the approval of the Board of Directors."

The Board Order read as 2<sup>nd</sup> paper stands modified to the above extent.
