ORDER

During the period of disastrous flood in Kerala, certain employees of KSEB Ltd were unable to reach office due to heavy rainfall, land slides and destruction of infrastructural facilities. They have requested to grant special casual leave / duty leave for period of such absence. It was also requested to grant compensatory off / special casual leave to those employees who have engaged themselves for power restoration works (Mission Reconnect) during the intervening holidays from 15.08.2018 to 31.08.2018.

The matter was discussed by the Full Time Directors in the meeting held on 25.09.2018 as per note read as (2) above and the FTD resolved to adopt Government Order dated 19.08.2018 for implementation in KSEB Ltd. and to grant Compensatory Off to the employees of KSEB Ltd. who have engaged themselves in activities associated with relief and restoration of power supply subject to eligibility as per relevant rules in KSR.

Further resolved that the absence / inability of KSEB Ltd. employees to attend office for official duties due to devastating floods, land slide and destruction of Infrastructural facilities during the period from 15.08.2018 to 31.08.2018 will be treated as 'Duty' eligible for financial benefits pending decision taken in this regard by the State Government.


