ORDER

The KSEBL had constituted a committee to look into grievances or anomalies, if any, of employees with regard to the online transfer 2017 vide order read as 1st paper above. The committee is authorized to verify the cases and to recommend eligible cases to the Full Time Directors Meeting for final approval.

The appeal petitions received in response to general transfer – 2017 of Senior Assistants vide this office order read as 2nd paper above have been verified by the committee and certain cases were kept pending to reconsider subject to the availability of places and approval of Full Time Directors of KSEBL while the remaining petitions were declined finding it lacking substantial ground.

As such the proposals on the grievances recommended by the Grievance Redressal committee were placed before the Full Time Directors for final approval and the Full Time Directors have approved the same.

In the light of the above, transfer orders annexed herewith is issued. The remaining appealants, not included in this order shall be relieved forthwith, since their appeals are not approved by the Full Time Directors.

Appropriate decision on the transfer of Sl. Nos. 79, 119, 127, 172, 217, 652, 736, 775, 781 and 813 of the order read as 2nd paper above will be taken by the Grievance Redressal Committee based on the judgments in the Writ Petitions filed by them. The decisions on the appeals/Writ petitions filed by Senior Assistants not included in the transfer order read (2) above, will be made by the Grievance Redressal Committee based on merits forthwith.

The transfers and postings of Sl. Nos. 15, 132, 147, 153, 185, 232, 300, 315, 345, 352, 375, 401, 423, 491, 542, 595, 628, 641, 855, 902, 943, 1046, 1050, 1087, 1121 and 1218 issued as per order read as 2nd paper above which are kept pending by the Grievance Redressal Committee are cancelled and decided to retain them in their present office.

The transfers and postings shown in the annexure are ordered in the exigencies of service and public interest.
