Selection for the post of Member in the Haryana Electricity Regulatory Commission Sir.

The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two Members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. One post of the member would be vacant in HERC on 11.02.2019 due to completion of the tenure of one of the present members. A suitable person has to be selected for this post and a Selection Committee has been constituted for this purpose.

- The qualifications for appointment of Member of State Commission and their term of office and conditions of service are provided in Section 84 and 89 of the Electricity Act, 2003, respectively. Pay and allowances of Chairperson and Members of the State Commission have been provided in Rule-3 of the Haryana Electricity Regulatory Commission (conditions of service of Chairman and Members) Rules, 1998 and amended vide notification dated 20.05.2009. An extract of Section 84, 89 of the Electricity Act, 2003 and Section-3 of the aforementioned rules is
- As per Section 84 of the Electricity Act 2003, the Chairperson and the Member of the State Commission shall be person of ability, integrity and standing who has adequate knowledge of and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. The chairperson and the Member of the State Commission shall not hold any other office as provided in sub-section (3) of Section 84 of the Electricity Act, 2003.
- The Chairperson and the Member shall hold office for a term of five years from the date he enters upon his office provided that no Chairperson or Member shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act, 2003.
- As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules, 1998 as amended vide notification dated 20.05.2009, pay of Members shall be in the HAG Plus Scale of Rs. 75,500 - 80,000/- per month with grade pay nil and an annual increment at the rate of 3% subject to deduction of the gross amount of pension including any commuted portion thereof if already getting.

- I am directed to request you to give wide publicity and also to send the applications of the eligible and willing candidates, if any, with the following information:-
 - A) The bio-data of the proposed candidate should include the following details alongwith his/ her signature and date:
 - Name
 - ii) Age & Date of Birth
 - iii) Position now held
 - iv) **Educational Qualifications**
 - Details of posts previously held and experience in any of the field of V.) engineering, finance, commerce, economics, law or management.
 - The communication should contain a letter from the person proposed intimating the details of any office, employment or consultancy agreement or arrangement which he/she has in his/her own name or in any firm, association or persons or body corporate. or in the names of any relative, carrying on any of the following business; namely:-
 - Generation, transmission, distribution or supply of electricity. ii)
 - Manufacture, sale or supply of any fuel for generation of electricity
 - Manufacture, sale, lease, hire or otherwise, supply or dealing in iii) machinery, plant, equivalent, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity and
 - Any entity providing professional services or any of the business referred iv) to in sub-clause (i), (ii) and (iii) above.
 - In addition to the above data, communication should also include a letter of willingness to resign his/her post and to join Member HERC if selected.
 - A declaration in the form of undertaking is also required to be submitted along with the application on the following points:
 - That he/ she does not have any financial or other interest which is likely to i) affect prejudicially his/ her function as Member, Haryana Electricity Regulatory Commission.
 - Whether any criminal case has been registered against applicant? ii)
 - iii) Whether applicant has been charge-sheeted for any criminal offence? If yes, the details thereof.
 - Whether applicant has been convicted by any competent court for any iv) criminal offence? If yes, the details thereof.
