ORDER

As per order referred above, considering the instructions issued by Election Commission of India, the Chief Electoral Officer has clarified that the day following the date of poll, and in case of re-poll, the date following the date of re-poll, as the case may be in connection with the General Elections to Lok Sabha, 2019 will also be treated as period of Election Duty and the Polling personnel are not required to report for duty in their normal place on such day. It is also clarified that in areas where the travelling time is longer, suitable further time will be made for this and the day following the date of deposit of polled materials etc. shall be treated as duty period.

Having considered the above, sanction is hereby accorded for treating the day following the date of poll / re-poll as the case may be as period of Election duty on behalf of employees of KSEB Ltd who have been posted for Election duty in the General Election to Lok Sabha, 2019.


